High rents and home prices make Berkeley unaffordable. People can't find housing. Renters live in fear of eviction. Let's change this.

Speakers

Stephen Barton, Ph.D., former director of Housing Department and deputy director of the Rent Stabilization Program in Berkeley:

A substantial part of rent paid by Berkeley tenants is not necessary to profitably operate and maintain rental housing, but rather an “admission charge” for the privilege of living here. Economists call this “land rent” and recognize the value of land is a creation of the larger society. The public is entitled to regulate or recapture the value the public has created. This insight is fundamental to progressive housing policies, including rent stabilization, exactions from developers, and the proposed windfall profits tax on landlords. The public has a right is to use these funding sources to create socially-owned housing through community land



trusts, limited-equity cooperatives and non-profit housing corporations.

Moni Law, Affordable Housing Activist

Gentrification, the process of developing a poorer neighborhood into an upscale one, has economic benefits and negative impacts: specifically the displacement of poor, working class people, and people of color. This is especially problematic in rapidly gentrifying area of South and West Berkeley. Potential solutions will be shared on how to retain a vibrant multicultural community in the face of developer pressures and 'high end' market forces.



Rick Lewis, Executive Director, Bay Area Community Land Trust (BACLT) and former Housing Advisory Commission Member:

Rick will discuss Community Land Trusts and cooperatives as positive models of affordable housing, explaining how these differ from generic affordable rental housing, as a democratic model building resident and community empowerment. He will also present some local models and show how BACLT has worked to continue Berkeley's strong tradition of resident-controlled housing with the *Brown Shingle Collective*.



Austin Pritzkat, President, Berkeley Student Cooperative and member of ASUC Senate

Austin will focus on the affordable housing crisis and the privatization of public higher education, their impacts on students and educational access, and the role of student cooperatives in creating affordable housing and preserving educational access.



Katherine Harr, Berkeley Tenants Union

In addition to Berkeley's need for additional permanent affordable housing, we must protect, preserve and improve our existing rental housing. Current efforts to reinterpret and revise the Demolition Ordinance are needed to support one-for-one replacement of rent-controlled units with permanently

affordable housing. Many recent demolition applications have been for housing that has been shamefully neglected. Efforts toward preservation of rental housing must include revisions to the Rental Housing Safety Ordinance.

SPEAK OUT FOR RENT-CONTROLLED HOUSING

Berkeley Tenants Union needs folk to come out to the City Council Meeting on Tuesday November 17th at 7 pm to support their appeal of the demolition of an 18-unit rent controlled building at 2631 Durant.

The applicant systematically destroyed the building by emptying it and allowing it to sit vacant, ignoring the blight ordinance and multiple city warnings to secure the building against trespassers, inviting the fire department to knock down walls and chainsaw holes in the roof, all for the purpose of gaining a permit under the demolition ordinance. This brazen approach to real estate speculation must be discouraged.

If we don't stop this demolition by having lots of people speak out, the current demolition ordinance means nothing anymore. If they will tear down 18 rent-controlled units that were occupied when the demolition was applied for, they will tear down anything. *Note: This is Item 21 on the November 17th City Council Action Calendar.*


